#### Dear Judge Abrams:

I have known Devon Archer for 23 years--since I arrived at Yale University as an 18 year old freshman. Through that time, he has been a friend, teammate, and business partner. He is one of the few people in my life outside of my family who I have had such a long term relationship with and I would like to explain the reasons for that.

When I arrived at Yale, I chose to walk on to the lacrosse team. In the Ivy League sports hierarchy, there is nothing lower than a freshman walk on. Most don't make the team and few last very long. At that time Devon was both a senior and one of the stars of the team. While most of his peers would not even acknowledge me, Devon went out of his way to make me feel like part of the group. He would drive me to practice, and even stick up (at an obvious personal cost) when other seniors would try to bully me. To me, the real test of someone's character is how they treat those people that have nothing to offer them in return; that was our dynamic when we first met and I will never forget it. I went on to have a successful four year lacrosse career at Yale, and I'm not sure I would have made it through that first year without Devon's help and encouragement. I also tried to take that lesson I received when the tables were turned and I was the star senior on the team.

Upon graduation, Devon and I remained close in my post collegiate years. Those years after college are interesting from a friendship perspective. Many whom I considered my closest friends in college either quickly or slowly drifted away from me, to the point where I would not consider them more than an acquaintance a few years removed from graduation. A powerful realization at a young age that many of these "bonds for life" were nothing more than friendships of proximity and convenience. Meanwhile, there were a select few college friends where the bonds actually grew stronger in those post graduate years. Devon was one of those friends. We shared a lot in terms of ambitions, business interests, character, meeting our future wives early, desire for large families, etc.

Our bond truly strengthened when we went into business together. It is worth diving into that part of our relationship because I believe it is what most exemplifies Devon's character and ethics. I am also a believer that actions speak louder than words, and it should become clear that I would not have entered into this transaction with Devon if I did not 100% believe in Devon, his judgement and his ethics.

Since 2008 I have sat as one of two Sohn family representatives on the board of directors of our family business, Lone Rock Resources. Lone Rock is entirely family owned, and the shareholders consist of my parents, my brother, my children, my cousins, my aunts, and my uncles. Lone Rock has historically been a timber management company although starting in about 2009, we decided to diversify outside of our core timber competence. When Devon and I started discussing a business he was building called Rosemont Realty, I immediately recognized it as an excellent potential fit for Lone Rock Resources, and thus began the most successful and by an order of magnitude largest investment Lone Rock Resources had made to date outside of timber.

The Lone Rock and Rosemont marriage lasted from our entrance in 2010 to our successful exit in 2015 where we made over 2X on our roughly \$60 million invested capital. Those numbers are not the point I am trying to make here, however. By bringing this transaction to Lone Rock and vouching for it, I put my reputation and family relationships on the line. Make no mistake, if this transaction had gone south it would have fallen on me and I would have to answer to every single family member. As the board and family member pushing for diversification, I understood that whole push would be dead if this deal ended badly. Even more directly, if anything had gone wrong through Devon's actions or inaction that would have fallen squarely on me at the board and family level. Yet I entered this transaction without hesitation because of the confidence I had in Devon as a businessman, investor, and person.

Throughout the 5 year life of the deal, Devon acted as a 100% ethical steward of our capital and a powerful advocate for Lone Rock. Just like at Yale 23 years earlier, there were times when Devon made ethical decisions in support of Lone Rock that either cost him financially personally or put important relationships of his at risk. And he did not hesitate to do so. Based on this consistent pattern of behavior that I have observed over decades, I would not hesitate to go into business with Devon again should the opportunity arise.

Dear Judge Abrams:

I have known Devon Archer of New York for several years, initially through friends, then in my business in the NY financials sector. A San Francisco native, my career has been in developing intellectual property, software and device technology for data analytics. The past 20 years included mergers and acquisitions and International consulting. In my fifty year career of international residency and travel, I have directly engaged with hundreds of business and government leaders. These circles broaden and expand as they ultimately narrow down as to whom one can trust. I have found that the ability to successfully make this judgment is not only worthwhile, but essential for success. This recognition ability is developed over much time and education. You learn to also listen to your gut.

The past few years have been centered on acquisitions and mergers to build a new worldwide company based upon the expertise and many patents held. This involved two American companies, in addition to one in France and in China. Financing by Bank of China, et al. New cash of \$100.0 million was planned.

During the course of this project we looked for financial management in New York. This required someone with financial institution and sovereign relations experience, especially with China and the Far East. Mr Archer was chosen to lead this effort. Over the next three years I worked with Mr. Archer on the multinational financing and other aspects of the venture. I associated with many people from several countries that had worked with him over many years. Without exception, Mr Archer was highly respected and universally admired for his character and integrity.

All who know him were staggered by the indictment that resulted in his trial before you. Many hours, days and months of incredibility and discussions. We were further shocked by the conviction and then joyful with your dismissal. During this period I spent considerable time with Mr. Archer. We tried to keep the financial agreements together, but the commitments with institutions, especially in China ultimately failed. All the principals Mr. Archer had dealt with supported him. But the "deal" and letters of intent and agreements were all tarnished by the litigation. Criminal securities involvement inevitability requires a further assessment of risk.

Knowing his integrity, no one I know believed he could be a cheater, let alone guilty of any fraud. But the diversion of his life, a question mark, a loss of business and reputation took a toll. A devoted family man dealing with his family on this, suspected. Terrible legal financial burdens.

However, the outward grace he displayed during this time was astounding. It is in my memories as a major accomplishment of character.

I am aware of his political involvement dating from his days at Yale. It is hard to avoid wondering if this recent judicial action by the U.S. Court of Appeals is not politically motivated because of Mr. Archer's long friendship and business association with Hunter Biden and the Democratic Party. It remains a continually waged character assassination by the Donald Trump campaign against the President Elect Biden.

Myself and his many friends remain steadfast in support of him, and this will continue. I hope that you will take consideration of the damages already inflicted on Mr. Archer and his family. He will remain an admired and productive person by all that know him and I highly recommend that he be allowed to continue that life where he can be such an influence for that integrity.

### Dear Judge Abrams:

I respectfully crave your indulgence to offer heartfelt words of support on behalf of my close friend and business associate, Devon Archer. I have never written a letter like this before so I apologize in advance if I overstep any boundary or violate any convention associated with letters of this ilk. That being said, I will confine my words to why I love Devon, and refrain from editorializing what I know about the case because I am neither a judge or a jury, merely his peer with whom he can depend upon as I always have in him.

I can personally attest to the anguish and despair my friend and his family have experienced throughout this distressing ordeal. Therefore, any way I can help relieve their pain and shed an honest light on the man often erroneously manufactured as a duplicitous, unethical boogeyman, it is my duty and privilege as his close friend to do so.

In any event, we visited New York for an unrelated matter and Tío Devon drove over from Brooklyn to our hotel in Manhattan to surprise Sofiana with tickets so he could see her excitement about being able to witness yet another Jets loss, but this time in living color.

So, now that I think of it, Devon might not be such a great guy because he granted her access to a massacre. All joking aside, we/she never asked for the tickets but he, being a terrific father, took it upon himself to not only purchase the tickets, but also hand deliver them so Tío Devon could experience that sheer joy with Sofiana.

As a fan of Frank Sinatra, I recall anecdotes about live audiences listening to him and each person feeling as though Sinatra sang only to them. Please do not relay to Devon that I am using a Sinatra analogy to attest to his character or his ego will never let me hear the end of it. Truthfully, though, that is how it feels to be around Devon; he makes you feel as though you are the only person in the room.

His attention to those who matter to him and his "I'm here for youness" lets people in and allows for deeper connections. It is that authentic connection with others that makes him such a trustworthy and reliable friend. Plus, he is an ebullient, worldly, self-effacing and charming guy so not only does he fully give of himself, but he also makes you better when he does.

Being in business with Devon is no different, as I have witnessed this social capital-driven, relationship-centric charm offensive in every corner of the globe. Whenever I hear the tired "it is not what you know, it is who you know" mantra, I slightly tweak it instead with "it is not who you know, but rather who you keep in touch with." Devon personifies this spectacularly, as his presence nurtures special relationships across sectors, industries and borders. He is a human LinkedIn but not in the way others expand their networks. Devon is a curator of friendships, not a collector of business cards.

The competitive advantage this "friend of the world" persona affords our business interests is immeasurable. I get courtside seats to see him connect with old friends or new acquaintances alike; a genuine connection of which I am fortunate to be a direct beneficiary.

I acknowledge this reads like a love letter but it is because I love my friend, and it is because of said attributes that I can understand why people wish to tear him down. It is easy not to like Devon because he possesses the qualities others envy, making him an easy target.

What saddens me most is although Devon is the one in the crosshairs, it does not exempt his family from becoming collateral damage. It hurts me to see my friend portrayed in the media as

a villain, rumored about as a shadowy figure in gossip columns and demonized on social media as a fraud. However, the injury it has caused his wife and her medical practice and the trauma it has inflicted upon his young children, namely his eldest son, hurts me more because that emotional vandalism is irreversible. The defamation of his name and his character will forever cast a shadow over any personal or professional pursuits.

I am providing this letter as a character reference for Devon Archer. I believe I am qualified to provide such a reference given my close working relationship with Devon over the last 5 years. Building a business is not easy feat. Building a technology company that spans the US, Latin America and Asia is even more challenging. Working closely with someone in the face of constant adversity and success provides deeper insights on the character of a colleague. Entrepreneurial teams are similar to hyper-competitive sport teams. We are constantly assessing each other's strengths and weaknesses on the field, and continuously working to improve how we cooperate and interplay.

By way of background, I am from the Philippines. I went to Middlebury College to pursue a liberal arts education, and completed the Owner President Management (OPM) at Harvard Business School. I also recently completed the Kauffman Fellowship in 2018 (Class 21). I serve as a director on the board of Atomic 47, a US fintech company that operates an electronic wallet. The goal of the company is to make cross border remittance better, faster and cheaper. I am also on the board of Mobile Pole Position (MPP), a Singapore fintech investment firm focused on Southeast Asia (SEA). MPP has invested in some of the most exciting fintech companies coming out of SEA. Devon has worked in a senior management capacity both in Atomic 47 and MPP during my tenure.

Over the last 5 years, I am proud to say that through direct efforts of Devon and myself, we have accomplished the following:

- Atomic 47 secured a technology licensing deal with Ipay commerce ventures (ipay), a leading
  fintech (remittance and ewallet operator) in the Philippines. Ipay is licensed by the central
  bank of the Philippines. Ipay seeks to provide basic financial services to the unbanked (70%
  of the Philippines).
- Atomic 47 has acquired a minority stake in MPP.
- MPP has invested in a range of companies in Southeast Asia including one of the fastest
  growing electronic remittance companies in Southeast Asia (Philippines, Indonesia, India), a
  ride-hailing platform, and virtual asset custody platform led by one of the former founders
  of one the leading custody platform in the USA.

In all of my dealings and work with Devon, he has exhibited discipline, hard work, commitment to the success of whichever project we were handling at that time, and integrity. I have had zero issues or 'red flags' at work over the last 5 years. As a serial entrepreneur and venture capital investor, I am trained to assess people and make a judgement call on their character. I have caught many bad apples over my career. I have no doubt on Devon's character and integrity in any of my dealings with him.

I hope this letter provides a reference point and more clarity through an unbiased lens. I would like to end with a quote from Socrates. "Is it true; is it kind, or is it necessary?" Devon's work with us

I am writing this letter on my bi-weekly flight from Beijing to Shanghai where I spend the weekend visiting with my father, a Parkinson's patient. This letter of course has nothing to do with my father, or with Parkinson's disease, it is a character reference in support of Devon Archer. I am certain others will attest to Devon's caring and loving nature as a spouse, as a father, as a friend, but for me, his sincerity and kindness are reflected in his support and concerns for my father and for my frustrations in dealing with my father's worsening condition. I first met Devon four years ago in his capacity as a business partner to the private equity firm that I had just joined, and throughout the years, notwithstanding the distance between New York and Beijing or the squabbles we often have over investment decisions, he has become a friend, and the friend I know would never knowingly commit fraud or knowingly participate in any fraudulent activities.

As the child of a first generation immigrant and a lawyer by training, I have always been of a reserved and cautious nature, a trait (or some might argue, a burden) which I carry when fraternizing with others. My relationship with Devon started on professional footings, he was, in my initial impressions acquired from discussing investment opportunities with him, positive and optimistic to the point of child-like buoyancy — he was always excited about new prospects, he was quick to trust, he was easy to engage and above all, he never wavered in hope. Our professional relationship slowly evolved into a personal friendship as he helped me ease into my new position as a private equity fund manager. He would jubilantly introduce me to his various contacts, relentlessly send me investment decks to scrutinize and resolutely challenge my lawyerly skeptical ways. As I got to know him and his family better, what I first took to be gullibility turned out to be a genuine willingness to give people the benefit of the doubt. "To trust as one would expect to be trusted" was something he practiced, and it sounds great as a bumper sticker, but so does "reality bites".

I believe that one's character, good or otherwise, is not easily discerned through the lens of routine observations but best manifested in unexpected circumstances. When the allegations of securities fraud surfaced, we were all disheartened but Devon maintained his innocence and his optimism. He is certainly not innocent of poor judgement or lack of due diligence but I do believe that he is innocent of any ill intentions and that his involvement is the unfortunate result of a grievously misplaced trust. In the months following the indictment and throughout the trial, Devon kept going with his social and business responsibilities, remained optimistic, and always

inquired after Daddy Wang – to me, this simple "how is he doing" is a testament of his good-natured character.

The law and the violation of which call for consequences, neither ignorance of the law nor ignorance of one's unwitting role in violating the law is an excuse for the resulting violations and injuries. Devon needs to and will own his mistakes and his share of responsibilities in the injuries committed, however, as his friend, I write to share a different perspective of his character, a perspective which may not have been apparent in the evidence presented to your honor but which may be fundamental in your judgement of him.

Allow me, please, to offer a few words of strong support on behalf of one, Devon Archer.

We met through a humanitarian project back in 1997, shortly after he had relocated to Hanoi, Vietnam, having been placed there by Citi Bank for an assignment in their main headquarters. At that time I was Executive Director of World Team Sports, an international sports charity, based at that time in Charlotte, North Carolina. We had been introduced through mutual friends and through a great humanitarian who was doing work in Vietnam. I was responsible for negotiating with the Vietnamese government around a spectacular sports event which was to take place the following year—and we were in need of garnering support, from both the Vietnamese government and from American based businesses in Vietnam. Mr. Archer immediately grasped the importance of our project—largety because he is the son of a Vietnam veteran, and we were there putting plans together to bring both veterans of the war years together. Because of our faith and upbringing, it was important to have our son baptized and to be given godparents—important figures in their lives to help shape them, provide good and decent and moral influences, and to be there if something were even to happen to us. It was an easy decision when selecting our son's godfather. Devon Archer was selected, present at his baptism and has, now, been a fixture in our son's life. He is there to protect and to support and to demonstrate a sense of caring and love for mankind. Our son has stood by during these challenging times. Our son believes Devon Archer to be a good and decent and honorable man. Our son believes in his godfather, and will be there, always to support him. My wife and I do, too. He is a man full of goodness and he cares deeply about what is important in this world, and he believes we are here to protect and support, and to love each other. We have seen that first hand, even in the last several months as he has interacted, communicated and spoken to our son about the consequences of his life—what they mean, and what we all have to do, again, to reconcile. I share these words from our own personal and uniques experiences over the last two decades with Devon Archer.
