FYI, the story has reached the Ukrainian press. No new details, since they are basically copying the WSJ article, but leading with a focus on Devon and Burisma. Here are a few relevant paragraphs translated.

Arrest in the company of the fugitive ex-minister Zlochevsky

One of the directors of Burisma Holdings, the Ukrainian gas company of the fugitive ex-minister Nikolai Zlochevsky, is accused of securities fraud

Devon Archer, investor and director on the Board of Directors for Burisma, was arrested on suspicion of securities fraud. This was reported by *Wall Street Journal* journalist Oliver Bullough.

The U.S. Securities and Exchange Commission accused Devon Archer and six of his partners of deceiving investors in the sale of more than \$43 million in fake bonds issued in 2014 and 2015 by the Ogala Sioux Nation.

Devon Archer was appointed a director on Burisma's board in April 2014. According to the Wall Street Journal, Archer was an advisor in the presidential campaign of John Kerry.

Burisma Holdings belongs to the ex-minister of Ecology and Natural Resources Nikolai Zlochevsky. The National Anti-Corruption Bureau of Ukraine is leading a pre-trial inquiry against him. The ex-minister is suspected of unlawful enrichment.
