I hope everyone is having a wonderful day. I've added another YouTube frequent flier – Julie Green Ministries – at [REDACTED] suggestion (thanks, [REDACTED]). She is just as bad as the folks who have previously gotten taken down, but she has a habit of using replacement words/coded language to avoid getting scraped by any of the filters meant to pick up on misinformation. As an example, she won't say "ballots". Instead, she'll say "those pieces of paper" or "ballets" and then follow that with "you know what I mean". She's engaging in misinformation dog whistling and YouTube hasn't caught it yet.

With that being said, let's jump right in.

And she's back! Looks like the account was unsususpended, so we've got several videos from her this morning. The first video was stunning.

This was a panel discussion she took part in on Bobby Piton's channel. He went way deep into conspiracy theory territory arguing that information is being maintained for an "omega set" and a "sigma algebra set". They used the example of a grocery store where the "omega set" is everything that is sold in the store while the "sigma algebra set" is smaller subgroups like meat, cheese, etc. They are arguing that the ballot process is being used to gather data on individual voters and he suggested this has been maintained for an undetermined number of years.

Another contributor said that he thinks we have a system of precincts connected and we add votes for one candidate of people who don't exist in order to arrive at a desired outcome. They ended by saying it was all a Chinese plot with Chinese people moving in and getting fake ballots to steal the country.

These people all agree with this, because not one person said a word in disagreement.

This was a video of a panel discussion with Josh Bernstein and Ron Ludders.

They talked a lot about the development of COVID.

They claimed that COVID was a biological weapon that was developed on purpose for deployment using funding from Dr. Fauci and other Americans who did not support former President Trump.

They provided updates on the appropriations committee voting to strip Secretary Hobbs of her roles, the issues between Mike Lindell and the NGA, all from the perspective of the far-right Q-Anon perspective.

She talked extensively about SB 1713. She was obviously very much in favor of this and even went after Phoenix sports teams who disagreed with the bill.

She was also pushing (again) the recall against House Speaker Rusty Bowers.

Other than that, all she did in this was re-post content from others (interviews with Mike Lindell, Paul Gosar, videos from Saturday's event at Dream City Church, etc.)

This is a phone interview John Brakey did with Ron Ludders.

He repeated the charge that the county did not turn over servers and ballot images. This is the repeating of a lie that has already been disproven. He also said that the audit was "damaged" by not being done at MCTEC.

He also suggested using the ballot images to compare with physical ballots and then releasing them publicly. This is useful because we now have an audit person on record calling for the violation of state and Federal law regarding the confidentiality of the ballot. Good Morning, All:

Hope you all had a great week. Gail Golec is back with a video in which she claims there will be hundreds of thousands of people at the AZ Capitol unless the 2020 Arizona election results are de-certified. She also made what seems like a direct threat of violent action if nothing is done with the results from the audit when they are published, so that was definitely the “highlight” of this week.

With that, here is this week’s update.

This is a rebroadcast of a 2015 concert from Ted Nugent. With a video this old, nothing much except worship of “Uncle Ted” Nugent.

This was an update from Lyle Rapacki.

He started by talking about how the movement of the machines and the ballots was “planned” and that they are recounting some of the ballots. This is not what the audit folks are saying, so this seems like another attempt at spin to try and paint this as something other than the disaster that it has been.

He claimed that the state Senate will issue a formal report. He claimed that the Cyber Ninjas will share their findings and the Senate will issue a report. Again, this is exactly the opposite of what Karen Fann has been saying. Two diametrically opposed statements cannot both be true at the same time.

He also said that by Wednesday, the Cyber Ninjas will be out of Phoenix. This is not at all what we have been hearing – if they are leaving tomorrow, we should have been called to get the ballots and machines and that has not happened.

This was a Fourth of July video in which they attempted to claim that the audit is the next front in the American Revolution.

They demonstrate an understanding of history which is, at best, shallow. They make claims that the British were sending soldiers to America to take back control after the signing of the Declaration of Independence. British soldiers had already been occupying America, they had blockaded Boston from the rest of the country and the Massachusetts militia was already doing battle with the British since 1774.

Aside from the obvious historical inaccuracy, I will avoid further comment.

This was a re-broadcast of “Right Side Broadcasting” that tried to claim that Antifa infiltrators were the ones who perpetrated violence on January 6.

This was a propaganda video promoting Jake Angeli as a “local icon” who didn’t storm through the Capitol.

This is a clear attempt to try and paint him as a great guy instead of the domestic terrorist that people saw on January 6.

This was a video to announce that Jake Angeli had been denied bail and that they were going to be planning a protest rally outside of the jail on July 14.

They used a video that claims to show Angeli as a peaceful protestor who had a right to gather, that he walked through an open door. What they fail to mention, of course, is that others in the crowd had forced those doors open and had assaulted officers. This is classic propaganda in defense of a domestic terrorist in which they claim he is a “political prisoner”.

There will be a rally that will be held on July 14. We may want to consider passing along this information to the Maricopa County Sheriff’s Office.

This was an update from Steve Bannon’s War Room with Jordan from Gateway Pundit. He claimed that the county is not being compliant and repeated the charge about a voter breach. They talked about this extensively and said that if an individual was able to access the website, that they should turn over the routers.

They completely mischaracterized what happened in November, this was one lie after another. They accused us of covering up and said we didn’t release any information and have taken no corrective action, which is flat out false.

They claimed that the audit is recounting ballots themselves. The problem is, that is flat out false. The state Senate is getting these counting machines to verify the shoddy work done by the “audit”. This demonstrates the pathological level of dishonesty by both Steve Bannon and the Gateway Pundit.

This was an update from Lyle Rapacki.

He covered the audit in Pennsylvania about the forensic evaluation ordered by Pennsylvania and which is modeled on what is happening in Pennsylvania. The cancer in our political system is metastasizing.

Senator Mastriano sent a letter to counties in Pennsylvania indicating what materials are wanted before July 31. If the counties do not provide the materials as requested, the committee Senator Mastriano chairs will then issue subpoenas, almost exactly the same process as the one Arizona experienced in December of 2020.

This was a video posted with a presentation by Douglas Frank that provided data sets that claim to demonstrate fraud. Much like a lot of the stop the steal presentations, they present this “data” and claim it proves their case without ever making the connection. It’s bad math, bad presentation and completely unreliable.

This is the first video posted to the YouTube channel since June of 2020.

She said they are not getting any updates because “if you give them something to attack, they’re going to attach it”. If this is to be believed, then it seems they have information, they’re just not releasing it. I doubt she is in the loop on anything significant, but she is saying the quiet part out loud here.

She is now claiming that she was targeted along with the other YouTube content creators by Media Matters, or as she refers to it, “George Soros”. She calls herself a truth teller, which is rather hilarious.

She talked about the Legislature voting to sine die and said that the subpoenas cannot be enforced without a majority of the Legislature. She said, however, that people can go after “them” criminally, without ever specifying who “them” is.

She claims that “they have the evidence” of fraud but never specifies what it is.

She repeated the charge that they need routers and splunk logs and said the Board of Supervisors could be criminally charged for non-compliance over that.

She talked about raising money for the audit as well and encouraged people to donate money to fund the audit through the OANN site as well as pushing people to donate to her site.

She also mentioned Ken Bennett’s statement that there is no pathway to de-certifying the electoral votes. She insists that there is a way to de-certify the votes without actually saying what that is.

She said there will be hundreds of thousands of people at the state Capitol if the electoral votes from 2020 are not de-certified.

This is an exact quote: “They called January 6 an insurrection. Let them come back with the audit results that I believe we’re going to see and them do nothing and let them see what is going to happen.”

She referred to the people as the fourth branch of government. I’m not sure what government text she is referring to with this.

She said “we are at war” and that this is a war. She doesn’t specify who, but this is very disturbing rhetoric.

She also talked about the creation of the committee to respond to the audit report created by the Legislature before they voted to sine die. In that section of the video, she said the committee will be pushing for the following measures to be enacted:

Election Integrity Fund and Ballot Fraud Countermeasures

12. Requires any vendor that provides fraud countermeasures that are contained in or on the paper used for ballots to be ISO 27001 certified, ISO 17025 certified or ISO 9001:2015 certified.
13. Requires ballot fraud countermeasures to include the use of at least three of the following:
 - a) unique, controlled-supply watermarked clearing bank specification 1 security paper;
 - b) secure holographic foil that acts as a visual deterrent and anti-copy feature;
 - c) branded overprint of any hologram that personalizes the hologram with customer logo;
 - d) custom complex security background designs with banknote-level security;
 - e) secure variable digital infill;
 - f) thermochromic, tri-thermochromic, photochromic or optically variable inks;
 - g) stealth numbering in ultraviolet, infrared or taggant inks;

None of this will likely ever be adopted, but this is what they are pushing for.

She claims the ballots were not the same and that they did not all come from Runbeck. This is a lie – the ballots were either printed at Runbeck, we printed them through MCTEC or they were printed at the voting center.

She claims that there will be a bar code that will be used to track the vote. This would actually be less secure as the signature automatically allows for confirmation and tracking of ballots. A bar code would actually allow for cheating to be easier to do.

She also claims that Mark Zuckerberg had drop boxes all over the state. This is more false information being shared.

She said that Federal only voters didn't have to prove they were citizens and that they only voted for President and Senate. That is absolutely not true and shows that she does not understand how the system actually works.

She talked about the supposed "data breach" and the letter referred to by the Recorder. She then repeated the same line repeated by others that this is proof that the routers should be submitted. She also said the Recorder's letter was sent in December, a month before he took the oath of office. Once again, this is an example of misinformation from someone who doesn't understand how any of our systems work.

She said that none of the media are reporting about this. The reason they have not reported is because it's connected to an ongoing legal investigation. Someone who talks about the law clearly doesn't seem to understand how it works.

Good Morning, All:

Hope you all had a great week. There are two things of note for this week.

A lot of content creators, including Liz Harris and Doug TenNapel, have had their YouTube channels deleted for engaging in misinformation about the 2020 election and the Maricopa County audit. Those that haven't been terminated outright have no new content in over a week. Some of these folks are moving their content over to Rumble. I am continuing to check there as well and will provide links and summaries of those videos as well so we know what is being said.

The AZGOP is shifting their messaging. This may be a recognition of how the audit has gone, that they seem to be moving into more of a 2022-focused messaging campaign. I'll keep everyone apprised if and when this changes.

With all that said, here is this week's update.

Liz Harris

This was the last account for Liz Harris and it was terminated for violating YouTube's terms of service. So, this account is gone.

Scottsdale Studios

They claimed in this video that the announcement that the county will not be using the Dominion machines is an accidental admission that the machines can be compromised. Any machines can be compromised if they have full physical access to them. They either don't understand the difference between physical access to a machine versus remote access or they're not acknowledging the difference and hoping nobody calls them on it.

This is an appearance Mark Finchem did on Steve Bannon's War Room.

Finchem claimed that there will be a preliminary report on paper that will come out on Monday. Obviously, with everyone else saying they're not done yet and with ballots not even being returned, this would be problematic, to say the least.

They also asked if there would be any way to tell if there were more ballots than registered voters from Peter Navarro. He talked about finding ghost voters or treated that like a serious question instead of a ridiculous and disproven conspiracy theory.

They emphasized the canvass again — the next step is going to be a major push to allow their volunteers to canvass voters.

Finchem also talked about the paper ballots and called the electronic count "fictitious".

He went on beyond that and repeated the lie about ballots with ballot envelopes that were not signed or could not be verified. Again, this is a lie and provably so.

They talked about the routers and Finchem made the claim that the reason the routers have not been submitted is because they will show that there was online penetration of the data systems.

Peter Navarro asked about the routers being destroyed. Finchem used that and repeated the lie from the anonymous Twitter account that this would be "a major crime".

They also talked about the Legislature remaining in session — which is now a moot point — and Finchem talked about how "the hand of God is on this".

Finchem contradicted himself by saying the audit was about resolving discrepancies even though he has previously talked about returning former President Trump to power. It seems he is having a debate on the purpose of the audit — with himself.

When describing the kinematic artifacts, he talks about folding as proof the ballot was artificial. We know this is not true and a just the facts has talked about this.

He also said that Maricopa County gets their ballots printed "from all over the place". This is an utter lie — Runbeck prints all ballots as they have for years. This is a direct lie that he can be challenged on at an appropriate time.

They also talked about expanding the audit to Pinal and Pima Counties, which proves that they are looking to expand this. Their goal is for this to keep going.

They talked about the canvass and Finchem said there was a plan for a canvass. Senator Fann has said there would not be a canvass. Both cannot be true at the same time.

He also talked about the routers and the splunk logs.

This was an update provided on June 29, 2021 provided by Chris King, the AZGOP’s Assistant Sergeant at Arms.

Once again, not a whole lot about the audit—more of a broadside about immigration and criticizing the Biden Administration on that issue.

Good Morning, Everyone:

Hope you are doing well. Here is your morning video update. The big story these folks are picking up is a petition filed by Josh Barnett and Daniel Wood, two candidates for Congress in 2020 who were defeated by pretty wide margins. They are claiming that the companies which certified the machines in 2018 and 2020 allowed their certification to lapse and the EAC only updated that certification once the story was brought to light. They are alleging that Maricopa County was out of compliance with state and Federal election law and they want the court to invalidate the 2018 and 2020 elections, remove the officeholders who were elected for the last three years and appoint temporary replacements until new elections can be held. This is likely to be what we'll see more people talking about from the Q-Anon supporting folks, as they are embracing this theory to a significant degree.

Beyond reposting Kelli Ward's video update from May 10, this video highlighted Doug TanApel blasting Sheriff Penzone's statement about the reckless nature of the Senate's most recent demand. He accuses the Sheriff of lying and he says that because the Sheriff is a Democrat, that alone appears to be disqualifying. Not only does this person (DT) not have any background in law enforcement, but his statement also shows he doesn't understand how data storage is managed in Maricopa County.

Senator Borelli appeared in a video and repeated the statement audit supporters are making about the routers. It seems clear they are going on a full court press to challenge what the Sheriff is saying before a likely public hearing and court appearance.

They also claimed that Recorder Fontes chose the Dominion software. In fact, the county has had a contract with Dominion Software since the Purcell Administration in 1996. This is another example of misinformation from people who don't know the basics of county procurement, now or in the past.

This video started with a repeat of a lot of previously posted content. They mentioned that audit organizers are now asking for a minimum of 5 shifts and at least one back to back shift. This tells me they are having trouble getting volunteers or employees to do this.

She also referenced the canvassing, which she now says is not being done. This is exactly the opposite of what she said on videos yesterday.

This video also references Josh Bernstein talking about the Q-Anon theory that EAC certification was not done and they allege that the County was out of compliance with state and Federal election law because, allegedly, the machines were not validly certified for either the 2018 and 2020 elections. This references a "petition for quo warranto" filed by Daniel Wood and Josh Barnett

asking them to invalidate and remove anyone elected in 2018 and 2020 and appoint temporary replacements until new elections can be held.

This is an almost seven minute video that claims the Justice Department is harassing "peaceful patriots" in response to January 6.

These two videos are from the “Rally to Free Political Prisoners”. The first speaker was Matt Braynard from Look Ahead America who referred to January 6 as “boomers who were going on a self-guided tour of the Capitol.

The imagery in this group’s logo contains a version of the eagle that is very similar to that used by multiple white nationalist groups. The logo used is provided below.



He compared the events of January 6 to the protestors who protested at the confirmation hearings for Brett Kavanaugh.

He also referred to a “protest” they are planning at the jail in Washington where their so-called “political prisoners” are being held. They said this is being held during the last week in July, but no further details have been provided at this time.

Other speakers included Mark Finchem, Paul Gosar, Lyle Rapacki, Jake Angeli’s mother

This was an appearance Senator Sonny Borelli made on War Room with Steve Bannon. Borelli was using this to gin people up for yesterday’s Senate meeting.

He talked about the letter from the House and made the argument that this is a states’ right issue and that Congress should not be involved.

He also defended the canvass and said it is legal for people to canvass in connection with the audit by saying it’s legal to canvass after the fact. What he doesn’t acknowledge is that the people doing the canvass are under the auspices of the County Recorder or the Secretary of State. Sending conspiracy theory-tied auditors door-to-door is deeply concerning.

He also claimed there is an active conspiracy between the Secretary of State and the Board of Supervisors to “suppress” the work of the audit.

He repeated the lie that we hand picked the small number of ballots to be recounted and that what we did was not an audit, that it was a sampling. As a Legislator and a member of Legislative Leadership, Senator Borelli should know the limitations of the state statute. The fact that he pretends to not know any better lends credence to the belief that this is a purposeful attempt to deceive the public.

When Bannon asked about decertification, he said the Senate is prepared to do what they need to do. This is in direct opposition to what Karen Fann said yesterday. This is a fundamentally dishonest approach in which Karen Fann says one thing for the cameras while Sonny Borelli goes to these fringe channels and broadcasts and says the exact opposite.

This was an appearance on Steve Bannon's war room with Mark Finchem.

He inadvertently made a very good point about the suggestion about antivirus software. If a device is not connected to the internet, why would they need antivirus software updates?

This was another attempt by Ben Cotton to say something that sounds dangerous but is actually quite beside the point for the purpose for which these machines exist.

He also suggested that the "wiping" of records is deletion of material and is a felony. He further repeated the charge that we were removing printers and deleting evidence. So, once again, while Karen Fann was saying no one is accusing anyone of wrongdoing, Mark Finchem was doing exactly that.

He is now charging elections administrators with lawless criminal conspiracy on the part of both the Board of Supervisors and the elections department. As if that wasn't enough, he referred to the Board of Supervisors as the "party of davos" and then said there were 168,000 ballots that could not be counted. This is a major push to justify doing the canvass.

The focus of this video was on everything that is likely going to be the subject of the subpoena which is likely coming in the near future.

New Evidence Reveals GA Audit Fraud and Massive Errors

ATLANTA GA – Petitioners in a lawsuit organized by VoterGA to inspect Fulton County ballots have added **stunning claims** in their [amended complaint](#) and provided new evidence from public records that show Fulton County's [hand count audit](#) of the November 3rd 2020 election was **riddled with massive errors and provable fraud**.

Most new allegations and evidence are based on a VoterGA data team's analysis of Fulton's November 2020 [mail-in ballot images](#) made public after petitioners won a court order on April 13th and VoterGA lobbying efforts led the Georgia General Assembly to make all images public under Open Records Requests beginning March 25th.

The team's analysis revealed that 923 of 1539 mail-in ballot batch files contained votes incorrectly reported in Fulton's official November 3rd 2020 results. These inaccuracies are due to discrepancies in votes for Donald Trump, Joe Biden and total votes cast compared to their reported audit totals for respective batches. Thus, **the error reporting rate in Fulton's hand count audit is a whopping 60%**.

One type of error discovered involved duplicate results reporting for batches of ballots. The team found at least 36 batches of mail-in ballots with 4,255 total extra votes were redundantly added into Fulton Co. audit results for the November election. These illicit votes include 3,390 extra votes for Joe Biden, 865 extra votes for Donald Trump and 43 extra votes for Jo Jorgenson.

But it is not simply a case of errors. **The VoterGA team found 7 falsified audit tally sheets containing fabricated vote totals for their respective batches.** For example, a batch containing 59 actual ballot images for Joe Biden, 42 for Donald Trump and 0 for Jo Jorgenson was reported as 100 for Biden and 0 for Trump. The seven batches of ballot images with 554 votes for Joe Biden, 140 votes for Donald Trump and 11 votes for Jo Jorgenson had tally sheets in the audit falsified to show 850 votes for Biden, 0 votes for Trump and 0 votes for Jorgenson.

Fulton Co. failed to include over 100,000 tally sheets, including more than 50,000 from mail-in ballots, when the results were originally published for the full hand count audit conducted by the office of the Secretary of State for the November 3rd 2020 election. Those tally sheets remained missing until late February when the county supplemented their original audit results.

Petitioners contend that Fulton County did not provide drop box transfer forms for at least three pickup days when obligated to do so via an Open Records Request. Those missing forms are still needed to provide chain of custody proof for about 5,000 ballots.

The VoterGA data team also found over 200 Fulton County mail-in ballot images containing votes not included in the hand count audit results for the November election. All these anomalies are now included in the Fulton County ballot inspection lawsuit as additional counts of how the Equal Protection and Due Process Constitutional rights of Georgia voters were violated.

They are alleging as “indisputable proof” that duplicate copies of ballots were scanned multiple times. Since there is no identifying information on the ballots they cited, however, there is no way to verify that.

She talked about Senator Fann’s interview on KTAR in general terms and claimed this as proof of wrongdoing. She also claims that people can be hung or shot (starts at 23:27) and suggested that the Board of Supervisors would be subject to that.

She also said that the ballots should not be returned, that they should be retained until all court cases are resolved. She suggested that when you give ballots back to “the enemy” (that is her reference to the county), that “who knows what will happen” (starts at 24:25).

During the discussion of the Board of Supervisor, she read her letter to the Board. In that letter, she accused the Board of Supervisors for treason and said the Board is part of the “protected class”.

She rambled about former Attorney General Bill Barr traveling overseas as further proof of the “protected class”. One of her viewers talked about her rational perspective – that is presented without further comment.

She claims it is “propaganda” that the election cannot be overturned. She did say she doesn’t know why we’re doing the audit if it is not to overturn the election. This is saying the quiet part out loud. She absolutely believes, as do her followers, that the 2020 election cycle will be overturned.

She also alleges that there is no indication about what happened from when ballots went off the truck versus on the truck. The trucks were sealed and not opened until the auditors could certify they had not been opened. This is another example of someone who has not one earthly idea what she is talking about.

She suggested putting the ballots in a big field and counting them there. She also suggested putting the Dominion machines in a field and blowing them up. That is presented without further comment.

She continued the theme of doing audits in every state. Literally, they want to keep this going without regard to the consequences for our system of government.

She said she was frustrated with President Trump for having walked away. She is literally arguing for martial law and for President Trump to have refused to leave office.

She also claims Arizona can de-certify elections and said that they probably will. She claims that she has spoken to Senators who have said the election can be de-certified. Not a single Senator has said that, so she is absolutely lying about this.

She ended by saying that war is for the rich and that “we are engaged in a war” and saying people pushing for the audit have been “vindicated”.

She started by claiming the hand count was over except for the Braille Ballots and that they are now inspecting the paper and the marks on the ballots.

She also put the Justice Department and the Attorney General on blast while promoting the letter sent by Attorney General Brnovich.

It is interesting that Dr. Ward said there would be “many, many, many times in the future” when leaders would have to tell the Biden Administration to “butt out”. That’s the first sign she has given publicly, slim though it is, that the 2020 elections will not be de-certified.
