JOINT STATUS REPORT

On September 6, 2023, the Court by Minute Order directed the parties to file a Joint Status Report by November 6, 2023, and every 60 days thereafter. The last status report was filed on March 5, 2024. ECF No. 87.

Per the Court's Scheduling Order (ECF No. 74), discovery is scheduled to close 180 days after entry of a scheduling order in *White Coat Waste Project v. WMATA*, No. 23-cv-1866 (JEB) ("*White Coat*"). A scheduling order was entered in *White Coat* on February 22, 2024.

Accordingly, discovery in this case will close on Monday, August 19, 2024. Discovery in the *White Coat* case is scheduled to close on November 22, 2024.

Defendant has moved for *White Coat* to be consolidated with this case. ECF No. 77. Plaintiffs here and the Plaintiff in *White Coat* oppose. Briefing on that motion was completed on November 7, 2023.
