SECOND ORDER RE COMPLAINANT’S MOTIONS TO AMEND

In the December 4, 2024 Order re Complainant’s Motion to Amend, Complainant’s Motions to Amend were granted in part and denied in part.

If Complainant does so, for each claim raised to the Counselor, the Agency must use the earliest date that the claim was raised in Complainant’s respective Motions, *i.e.*, Complainant’s January 6, 2022 Motion to Amend, Complainant’s October 19, 2022 Motion for Leave to File Her Second Motion to Amend, and/or Complainant’s April 25, 2023 Motion for Leave to File Third Amended Complaint as the date of the counseling request for determining the timeliness of the claims for which Complainant’s Motions to Amend were denied.
